

## **License Agreement (NON-EXCLUSIVE UNIQUE COMMERCIAL RIGHTS)**

With this license, I agree to the terms and conditions of using the beat(s) composed by Cassidy Rae Guerrero (Licensor), also known as 1 A.M.. Therefore I agree and understand:

**Credit.** the original authorship of the composition appropriately and reasonably in all forms of media, metadata, packaging, promotion and performance formats will be credited to the producer 1 A.M. (Cassidy Rae Guerrero). Credits will be given in such way to the producer as the name "Prod. by 1 A.M." or "Produced by 1 A.M." in writing, such as titles, wherever possible and vocally otherwise.

**Publishing & Royalties.** As the producer, Cassidy Rae Guerrero (1 A.M.) owns 50% of publishing rights/credits/points etc.. **Performance Rights.** I am granted to use the work created from using such beat(s) in paid performances, shows, and concerts.

**Synchronization Rights.** this license grants me permission to use the work that was created with 1 A.M.'s beat(s) in up to 2 music videos, and/or up to 2 videos for content creators.

**Broadcast Rights.** this license grants me permission to broadcast any of the work created that was created with the beat(s) composed by 1 A.M. (Cassidy Rae Guerrero) including radio, video games.

**Delivery.** the beat(s) shall be delivered via email to an email address that I have provided or in person (if applicable).

**Audio Samples.** 3rd party sample clearance is my responsibility.

If I violate the terms and conditions, I understand the licensor has the right to terminate this agreement and I will be held accountable under the law.
